#### JUDGES TO BE NONPARTISAN

Circuit Judges, M. Slusser of DuPage and D. J. Carnes of DeKalb County, have not accepted the nomination of the Aurora republican Caucus which named them and Frank R. Reid. The two judges have elected to stand by their agreement with Judge Clinton F. Irwin of Elgin, the other jurist now presiding in this circuit. Some time ago the three judges, who re-ceived the endorsement of the bar association of the counties comprising the district agreed to run as independents or nonpartisans, and thus take the staid and honorary title of judge out of politics.

The Aurora Caucus with three representatives from DuPage County, took the stand that three republican judges should be elected.

Judges, Carnes and Slusser remained republicans when the party split in 1912. Judge Irwin was elected on the Progressive ticket to fill the vacancy caused by the death of Judge Henry B. Willis of Elgin.

# JAMES B. WEBB, PIONEER DIES

James B. Webb, widely known as the founder of the Borrowed Time club, died Thursday afternoon at 2:30, in the home of his daughter, Mrs. Stella Manning. Father Webb as he was familiarly called, was in his 84th year, having passed the 83rd milestone on the second of January. He is survived by the four children, George D. Webb of Oak Park, Lew H. Webb of Lombard, Frank Webb of Lewiston, Idaho, and Mrs. Stella Manning of Lombard.

Mr. Webb was a life long Methodist. He was actively identified with the early days of the First Methodist Episcopal Church of Oak Park. Although a regular attendant of the Lombard Methodist Church, he never removed his membership from the Church to which he had given his best years.

He was responsible for the establishing of Philander Smith College in Little Rock Arkansas, and its auxiliary, Adeline Smith Hall for Girls. Webb Hall of Philander Smith College is named in his honor.

The funeral services will be conducted at 2:00 P. M. to-day in the First Methodist Episcopal Church of Oak Park. Brief services will be held with the decedent's family in Mrs. Manning's home at one o'clock. The Rev. John Norris Hall of Chicago, the Rev. Rufus J. Wycoff of Oak Park, and the Rev. Charles Nyman of Lombard will participate in the service of tribute to the departed "Father in Israel."

## FOREST RESERVE VOTE JUNE

The people of DuPage County on June 7, are to vote upon the establishment of a Forest Preserve District covering the entire county. No issue of more vital importance has been put before us as voters. Ιt presents an important and economic question, a new and progressive public policy which promises huge additions to the wealth of our county, in which we may join together in an effort to secure the benefits of the new law permitting the establishment of public forest areas in Illinois.

Here in brief are some of the provisions of the law which was passed by Illinois Legislature and signed by the Governor in 1913.

An area lying wholly within one County containing one or more cities, towns or villages and one or more natural forests may be incorporated as a Forest Preserve after going through the process of 500 voters of the County petitioning a Circuit Court Judge of said County to have the question submitted to the legal votes as to whether or not it shall be organized as a Forest Preserve district.

This district preserves the natural flora, fauna and scenic beauty in it, in their natural state for the education pleasure and recreation of the public, with paths, drives and roadways through the woods so incorporated, all taken care of by the county board as Forestry commissioners, without compensation



#### THE PLUMBING SITUATION ON

To The Editor,

Dear Sir: It would be an injustice to the Journeymen Plumbers of DuPage County in general and those of Glen Ellyn in particular if your article in last week's Glen Ellyn on the Plumbers walkout was allowed to pass unchallenged.

As the secretary of plumbers Local 507, of DuPage county, I wish to state that you were grossly misinformed as to the true reason

of the "walkout."

Suffice it to say that the master plumbers of DuPage county were given three months notice previous to May 1, of the new agreement which by the way is practically a repetition of the agreement existing between masters and men for the last two years, with the exception of an increase of from 60 cents an hour to 65 cents an hour (not 65 cents to 70 cents as reported).

This question of increase is left open. There was absolutely no effort on the part of the masters during the three months notice previous to expiration of old agreement V12, April 30, to meet the journeymen with reference to the new agreement.

After the consequent walkout the Masters met the Men and were willing to concede the "IF"- The Journeymen, since the Masters were willing to give the increase closed on it but the "IF"

The majority of Journeymen in this county are family citizens, and are just as much established as the Masters. It is unfair to either side to have facts misrepresented, and since the "Right to Live" necessitates a fight. I would refer any further queries to the Master Plumbers of DuPage County.

This reply has not had time to receive the endorsement of Local 507 of whose aquiesance I have no doubt, therefor I take the responsibility thereof.
